Following Open Public and Forum Group meetings, which took place in the Autumn of 2010, a number of residents and Councillors, who were interested in the future of Sandbach, formed the Town Plan Steering Group and Support Focus Groups.

The aim of these groups was to carry out an extensive survey with households, businesses and schools to identify issues of particular concern and to develop, where possible, courses of action to address these concerns. A questionnaire was delivered to all households in Sandbach. A separate questionnaire was completed by senior school pupils. This Action Plan has been produced following analysis of the results of these questionnaires.

The following is the summary Action Plan, produced as a result of this research. The Action Plan details each area of concern and action to be taken by the relevant Lead Organisation, whose agreement has already been sought.

The Steering Group has strived to reflect the views of all residents, businesses and schools that have been given as much opportunity as possible to join in the consultation process. We would like to thank the many people who have taken part along the way.
